SB0475	COSTA	D	2.11.13	An Act amending the act of October 27, 1955 (P.L.744, No.222), known as the Pennsylvania Human Relations Act, further providing for the definition of "employer."
SB0476	ARGALL	R	2.11.13	An Act establishing rights of correctional officers during certain investigations by the Department of Corrections; authorizing certain civil suits by correctional officers; and providing for impact of collective bargaining agreements and for summary suspensions.
